6. Reports

a. Construction Report (6:12)

Jennifer Hodges from Gourdie Fraser gave members a construction update. She is working with an attorney to finalize an easement to provide access to the water tank site for water system improvements. The Crown water access station project has been rebid and she met with the Drain Commissioner and Korn to look at the proposed Cass drainage district. Plan reviews are being reviewed for the Ridges at 45 and the Kings Court possible expansion. Blood Law asked for cost estimates for any projects to be done this year. Larrea verified that the Kings Court expansion project was not approved yet but that the owner was coming to the Planning Commission for a rezoning request.

b. Sheriff's Report (6:19)

Lieutenant Chris Barsheff said that there were 1342 total calls for the month of March, 2015 and 44% of the total calls were in Garfield Township. He says proactive efforts have helped fight crime and that the prosecutor's office is authorizing more complaints. The Sherriff's department is continuing to build relationships with hotels in the area and on March 10th, broke up a prostitution ring at one hotel. A case of retail fraud at Walmart was also solved. April 30th will be National Drug Take Back Day and the department will be talking to students at Traverse City West HS regarding prescription drug abuse.

c. Personnel Committee Report (6:29)

Schmuckal said that the Personnel Committee is interviewing five people for the Zoning Administrator position. Korn added that the committee may look at having more flexibility in the hiring process due to timing of vacancies.

d. Clerk's Report (6:31)

McManus said her report is in writing and added that she handed out the Grand Traverse County Board of Canvassers Report which showed that Garfield Township had no mistakes in the recent election because of the good work of her

receiving board and election workers. She thanked them for their long hours and dedicated work in the March primary election.

e. Supervisor's Report (6:33)

Korn reported that the Sonny's Body Shop zoning lawsuit has been settled and there is another case currently on appeal. He is continuing to work with officials on the TART trail.

f. County Commissioner's Report (6:35)

County Commissioner Alisa Kroupa reported that there was an annual equalization meeting and overall, county revenue is slightly down but Acme Township revenue is up due to the new Meijer's development. The Commission chose to remove the elected position of County Surveyor and appointed Bob Mitchell to the position, who will be paid with a grant. She said that there will be a study session next week regarding the proposed Veteran's Administration millage and they are moving forward with audits of the IT and Sheriff's departments.
