PLEASE TAKE FURTHER NOTICE that the items to be considered at the public hearings include, in brief, the following:

- 1. Consideration of an application submitted by Sarah Keever on behalf of Copper Ridge LLC for a Special Use Permit (SUP) major amendment of the Copper Ridge Planned Unit Development (PUD) located on the north side of Silver Lake Road, northeast of Barnes Road (parcel No. 05-096-900-00 and associated Copper Ridge parcels). The proposed amendment requests greater flexibility in designating the land use of the four (4) remaining unbuilt locations within the PUD that are being adjusted to accommodate three primary land uses: office, commercial, and residential. This amendment meets the objectives identified in Section 423.G of the Zoning Ordinance that incorporates different land uses in locations than requested in the original application and the potential to increase the number of residential dwelling units.
- 2. Consideration of an application submitted by Kyle Richter on behalf of RCI | Richter Construction, Inc. for a Special Use Permit (SUP) major amendment for an addition to the Cherryland Humane Society's existing facility at 1750 Ahlberg Drive (parcel No. 05-026-006-20). According to the application, the scope of work consists of two (2) building additions totaling 9,006 square feet to an existing 14,168 square-foot building.
- 3. Such other and further matters as may properly come before the Planning Commission at the public hearing.
