

OVERVIEW:

One of the 2024 priority parks projects is the design and construction of a trailhead for the Commons Natural Area at Copper Ridge. Commissioners reviewed a conceptual drawing for this project at the June 3, 2024 meeting. Since then, Staff conducted a site visit with the Township Engineer, Gourdie-Fraser (GFA), and members of the mountain bike subcommittee. GFA prepared an updated conceptual drawing of a preferred design based on feedback following this site visit. The updated conceptual design for the trailhead consists of the following:

- A 7-space parking area accessible from Forest Park Drive. This area was identified as a trailhead area on the original site plan for the Copper Ridge development.
- A trailhead area directly behind the parking area, to be surfaced with woodchips and allow for any potential future amenities. A 2-foot-tall retaining wall would also be installed on the edge of the trailhead area.
- Two crushed gravel trail segments, one 6-feet wide and one 4-feet wide to connect the trailhead to existing trail heading to and from the hill to the west. The proposed routing was altered for this trail to account for the steep slope and allow for a gentler grade for the trail, as well as to help prevent erosion. The width was also narrowed since the previously proposed route following an existing, wider two-track.
- A 4-foot-wide crushed gravel trail segment connecting to the existing trail towards the east, which is shown as a future phase.

Staff met with representatives from the Copper Ridge association and Surgery Center earlier in 2024 to discuss this trailhead and have forwarded this conceptual drawing to them for their feedback.

No amenities are described in this conceptual design but could be added as part of a future phase. GFA also provided an updated opinion of probable construction cost (OPCC) for the project.


ACTION REQUESTED:


MOTION TO RECOMMEND to the Township Board that a request for proposals (RFP) be published for the Copper Ridge Trailhead project.

OVERVIEW:

In October 2023, the Parks and Recreation Commission recommended a list of priority parks projects for 2024 to the Township Board. The Township Board ultimately adopted the overall 2024 Township budget including a parks budget with capital outlay portion identified. The total capital outlay shown in the parks budget reflected three of the four projects recommended by Commissioners. The status of these projects is as follows:

Project is anticipated to be supported by fundraising efforts of the mountain bike subcommittee. | GFA has prepared the design and estimated costs for this project. These are being reviewed by Commissioners and have received input from the mountain bikers. This project is anticipated for construction in fall 2024. |
| Grand Traverse Commons Natural Area: Red Drive Trailhead Engineering and Design | \$15,000 | Engineering and design for Red Drive trailhead as shown in the Commons Natural Area Design Plan, including design of the parking area, bathroom, and improved trail access. | This project is anticipated for fall 2024. |

Commissioners had also recommended a project for the engineering, design, and survey work in relation to the accessible trail loop project at the Grand Traverse Commons Natural Area, as a part of local match funding for the Michigan Natural Resources Trust Fund grant. This project is not reflected in the capital outlay portion of the 2024 parks budget. However, at their March 26, 2024 meeting, the Township Board approved a proposal for engineering services for this project from Gourdie-Fraser (GFA), the Township's Engineer of Record. Further, unused funds from the 2023 capital outlay for implementation of the Design Plan for the Commons Natural Area may potentially be used for this project.

2025 PRIORITY PARKS PROJECTS:

Several projects have been previously discussed as potential 2025 priority parks projects. Some facilities have also been identified as potentially requiring repairs. Potential priority parks projects to consider for 2025 include the following:

• Accessible Trail Loop (Grand Traverse Commons Natural Area)

At their March 26, 2024 regular meeting, the Township Board approved a proposal from GFA for engineering services for the accessible trail loop project at the Grand Traverse Commons Natural Area in the amount of \$77,500. The total local match for the grant is \$368,100 as identified in the grant application, so the anticipated cost attributed to the park budget for construction of the trail loop and other non-engineering expenses would be **\$290,600**.

• Pickleball Court Resurfacing (Boardman Valley Nature Preserve)

In early 2024, the Parks and Recreation Commission discussed resurfacing the pickleball courts at Boardman Valley Nature Preserve. The Township received a price guarantee from Hentco LLC for this project of **\$34,283**.

• Potential Pickleball Courts (Silver Lake Recreation Area)

Staff have heard from some residents who are advocating for installing pickleball courts at Silver Lake Recreation Area. There is an area between the existing tennis courts / basketball courts and the paved trail loop which could potentially house these courts. This area is identified as such on the Silver Lake Recreation Area Park Development Plan which is part of the Five-Year Parks and Recreation Plan. Staff can obtain a quote for the estimated cost of installing these courts.

ACTION REQUESTED:

The purpose of this item is for Commissioners to discuss the proposed priority parks project list for 2025. No action is required.
